## Epson printer mix colours to make black

By Lyan Uaha It is easy to print compact disc (CD)/digital versatile disc stickers (DVD) on an Epson printer using Epson PrintCD software. Epson provides this software with the printer when you buy it. For this purpose, use only the printable CD/DVD. Click Start, point to All Programs, click Epson, and then click Epson PrintCD. Click the Internal/Internal Diameter Size icon on the Epson PrintCD window toolbar that opens. If you don't know which toolbar icon is for the size of the internal/external diameter, point to and hold the mouse pointer on the toolbar icons to see the tool tip that indicates the name of the icon. Select the diameter of the CD/DVD label that you want to print by selecting the appropriate radio button in the Internal/External Diameter Settings dialog box that opens (for example, a 12cm CD/DVD), and then click OK. Click the Background icon on the toolbar to select the background for the CD/DVD tag. Click the Set Color radio button in the Background Options dialog box that opens to select one color as the background color for the CD/DVD tag, select the color of your choice by clicking the color button, and then clicking OK. Click the Graduation Radio button in the Background Options dialog box for a different color, click the Start Color button, and then select the color of your choice. Click the End Color button, and then select the color of your choice. Then click OK. Select the Picture radio button in the Background Options dialog box to select the picture as the background for the CD/DVD tag. Click the Select Picture button, select the picture in the Select Picture that opens dialog box, and then click OK. To select a picture stored on your computer, click the File tab in the Select Picture dialog box, click Browse, select the picture, and then click OK. Click the Picture Setup button, click the Template tab in the Customize Picture dialog box that opens, click and drag the picture you selected over the displayed CD format (part of the picture at the top of the CD format will be printed), and then click OK twice. Click the Text icon on the toolbar to add text to the CD tag. Click the Text tab in the Text Settings dialog box that opens, and in the Text box, type the text you want to insert on the CD label. Click the Text Settings tab, and then select the font style and font size of your choice for the text. Similarly, click the Text Color tab, and then select a color for the text. When you're done changing the text, click OK. Insert the printable CD/DVD on which you want to print the label in printing the Epson PRINTER CD/DVD.
